

ORDINANCE NO. 2016-4

AN ORDINANCE CREATING THE POSITION OF ASSISTANT VILLAGE FISCAL OFFICER, APPOINTING AMY ~~V~~BODICKA TO THE POSITION OF ASSISTANT FISCAL OFFICER, AUTHORIZING A RATE OF \$15.00 PER HOUR FOR SERVICES PROVIDED AND DECLARING AN EMERGENCY.

WHEREAS, Linda Petkosek intends to resign from her position as Fiscal Officer of the Village of Aquilla effective March 1, 2016; and

WHEREAS, the Council of the Village of Aquilla desires to create the position of Assistant Fiscal Officer and hire a person for that position; and

WHEREAS, the Assistant Fiscal officer will work with the Fiscal Officer to assist the Fiscal Officer in the performance of her duties and responsibilities.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Aquilla, Geauga County, Ohio, that:

**SECTION 1:** Effective January 1, 2016, the Council hereby creates the position of Assistant Fiscal Officer.

**SECTION 2:** The Assistant Fiscal Officer shall be paid the sum of \$15.00 per hour for services provided to the Village, *not to exceed 20 hours per month.*

**SECTION 3:** The Council appoints Amy ~~V~~Bodicka as the Assistant Fiscal Officer effective January 1, 2016; and to the position of Fiscal Officer effective March 1, 2016.


**SECTION 4:** Linda Petkosek shall be and hereby is appointed as the Assistant Fiscal Officer effective March 1, 2016, for the remainder of the calendar year 2016.

**SECTION 5:** Amy ~~V~~Bodicka shall be paid a salary of \$400.00 per month effective upon her appointment as Fiscal Officer.

**SECTION 6:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law, including §121.22 of the Ohio Revised Code.


**SECTION 7:** This ordinance is hereby declared to be an emergency measure for the public health, welfare and best interest of the residents of the Village of Aquilla; and for the further reason that the Council desires to appoint an Assistant to learn the duties and responsibilities of the Fiscal Officer, who will be resigning within the first quarter of the calendar year, and therefore this ordinance shall become effective upon its passage.
