

**ORDINANCE NO. 2017-2**

**AN ORDINANCE AUTHORIZING THE EMPLOYMENT OF A SOLICITOR FOR THE VILLAGE OF AQUILLA AND SETTING HIS COMPENSATION.**

**BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF AQUILLA THAT:**

**SECTION 1.** James Gillette be employed as Solicitor for the Village of Aquilla for the period beginning January 1, 2017 and ending December 31, 2017 at the rate of Eighty Dollars (\$80.00) per hour and to be paid at the end of each quarter by the Fiscal Officer.

**SECTION 2.** The Solicitor shall perform all the duties for solicitors, city attorneys, or directors of law set forth in Section 1903.34 of the O.R.C., including representing the Village in all pending cases in any court.

**SECTION 3.** During the time that James Gillette is temporarily absent or incapacitated or in such other proper case, said James Gillette may delegate the responsibility for representation to another attorney.

**SECTION 4.** All such substitutions or delegations made under Section 3 above shall be without any additional cost to the Village of Aquilla.

**SECTION 5.** The Clerk deliver two copies of this Ordinance to James M. Gillette; one copy to be returned noting his acceptance of the terms thereof.

**SECTION 6.** This Ordinance shall be retroactive to January 1, 2017.

**SECTION 7.** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all such deliberations of this Council and of any of its committees that resulted in formal action were in meetings open to the public in compliance with all legal requirements, including §121.22 of the Ohio Revised Code.

**SECTION 8.** This ordinance shall be in full force and effect on the earliest date allowed by law.
